Thank you for your letter of May 20, 2015, regarding the Nunavut Planning Commission's negative conformity determination on Baffinland Iron Mines Corporation's Mary River Phase 2 Project proposal.

In your letter, you express disappointment with the Nunavut Planning Commission's recent negative conformity decision because many community members from the Hamlet of Pond Inlet felt their participation or consent was not taken into account. I, likewise, feel it is important to hear the community's and your organization's concerns as I consider Baffinland's May 21, 2015 application for exemption from the conformity requirement.


Thank you for the invitation to meet with you in Pond Inlet to discuss matters as they relate to the Phase 2 proposal of the Mary River Project. I am regrettably unavailable; however, I am prepared to send Mr. Stephen Traynor, Acting Director General of the Natural Resources and Environment Branch, on my behalf to Pond Inlet next week, between June 1 and 7, to meet with you and community members if this timing will suit your needs. This meeting would be timely and would inform my decision on Baffinland's application for exemption.
