1.1 Context

The Nunavut Planning Commission (NPC) is preparing a land use plan to guide and direct resource use and development in the Nunavut Settlement Area (NSA). As part of its efforts, the NPC is facilitating discussions in each Nunavut community on land use and resource management issues. Information that is obtained from these discussions will be used to inform decisions regarding the further development of the Nunavut Land Use Plan (NLUP).

1.2 Purpose

This report presents information obtained during the NPC's visit to the community of Grise Fiord. The purpose of the report is to inform decisions regarding the further development of the NLUP, ensuring that the plan reflects the priorities and values of residents.

It is important to note that the information contained in the Community Report will be considered in conjunction with all other feedback when revising the DNLUP.

1.3 Methodology

Information was presented to and received from participants in Grise Fiord in accordance with the Nunavut Planning Commission's Community Engagement Strategy (Engagement Strategy). The Engagement Strategy provides for the following methods for presenting and receiving information;

- **Open house;** information contained in the Draft Nunavut Land Use Plan (DNLUP) was presented on 7 multi lingual large format poster boards. Participants were encouraged to review the posters, ask questions and provide feedback. Comments and questions were recorded by NPC staff and are contained in Appendix 1.
- **Elected Officials Meeting;** The NPC Chairperson and NPC staff met with senior and elected officials in the community. The development process for the DNLUP, its content and next steps were presented.

Comments and questions were recorded during the session and are contained in Appendix 2.

- **Public Workshop;** A formal presentation of the Draft Plan content was provided to participants, including a slide overview of its content. Following the presentation, questions and comments were received from participants. The questions, comments and responses are contained in Appendix 3.

A mapping session followed the presentation of the Draft Plan. The mapping session involved discussions regarding the topics presented in the DNLUP and encouraged participants to identify additional areas and issues important for inclusion in a NLUP. Information received during this session was recorded by NPC staff and is included in Appendix 4.

- **Wrap Up Session;** Staff was available to discuss the areas identified during the mapping and identify any additional issues or areas of interest.

Areas that participants identified during mapping sessions as important to a particular goal have, in the majority of cases, been included in this report as they were recorded. In instances where participants identified an area that was better suited to another goal, the area has been reclassified to the more suitable goal and has been verified as appropriate to do so by the Community.

A follow-up meeting was held on May 14, 2013 to review a draft version of this report with the Hamlet Council, Hunters and Trappers Organization, and Community Lands and Resource Committee. A summary of this meeting is included in Appendix 5.

1.4 Public Awareness

The NPC raised public awareness regarding its visit to Grise Fiord in accordance with the Engagement Strategy.

The DNLUP and supporting materials were mailed to the Mayor and Council of Grise Fiord, the Hunters and Trappers Organizations (HTO) in September 2012. In addition, letters of invitation were sent to the Grise Fiord Mayor and Council and

HTO in advance of the NPC's visit to advise of the meetings and to encourage participation. Follow up phone calls were also made.

Public notice of the various events was provided in the following ways:

- **Nunatsiaq News and Nunavut News/North;** notice of community meetings were posted in both newspapers a minimum of 45 days in advance.
- **Co-op cable TV;** notice of community meetings was run a minimum of 45 days in advance for one week and run again for no less than 14 days before the meetings.
- **Community radio;** notices were read by the hosts and a live interview with the Commission Chairperson was conducted.
- **Community bulletin boards;** notices were posted on bulletin boards around the community 45 days and again 14 days in advance of the meetings.
- **Community mail drop;** one page flyers that announced the meetings and their purpose were delivered to the post office in each community for all mail boxes that accept unaddressed ad-mail.
- **nunavut.ca;** the schedule of community visits, the Draft Plan, and all supporting information was available on the Commission's website.

1.5 Community Population and Participation

Grise Fiord is a community of approximately 130 people (Statistics Canada, 2011 Census). It is located on the southern coast of Ellesmere Island (see Figure 1).

The Commission visited the community on January 31 – February 1, 2013. All events occurred as scheduled. The sessions were attended as follows;

- **Elected Officials Meeting;** the Mayor and members of the Hamlet Council and HTO attended the elected officials meeting.
- **Open house;** approximately 10 people attended the open house to review the Draft Plan.
- **Public Workshop;** approximately 25 people attended the presentation of the DNLUP and facilitated mapping sessions. Information was recorded in 1 mapping group.
- **Wrap Up Session;** approximately 10 people attended the wrap up session.

Chapter 2: Protecting and Sustaining the Environment

Protecting and Sustaining the Environment was one of five topics presented to and discussed by participants during the Open House, Elected Officials Meeting, Public Workshop and Wrap up Session, collectively referred to in this document as information sharing and gathering sessions.

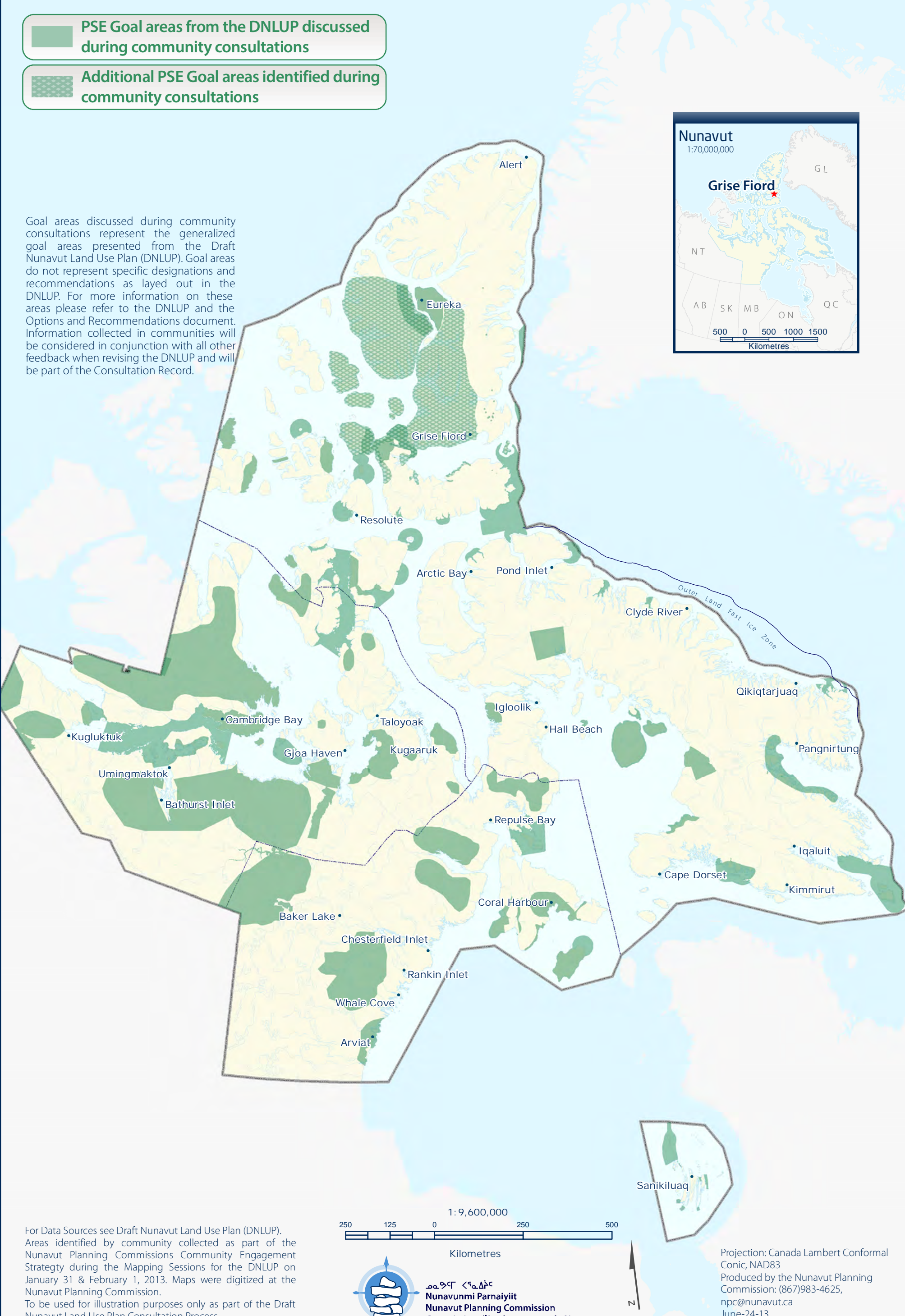

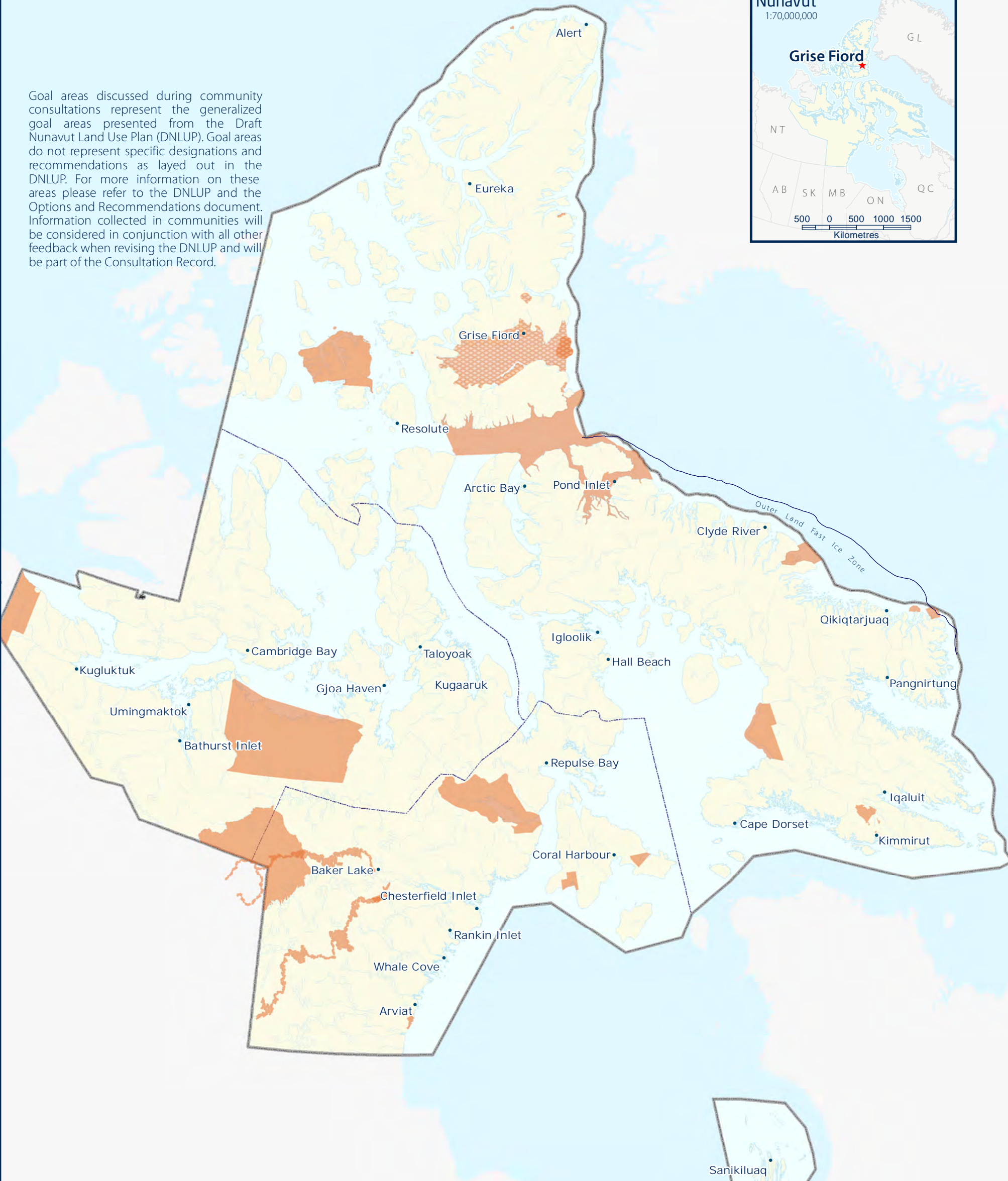


ECP Goal areas from the DNLUP discussed during community consultations

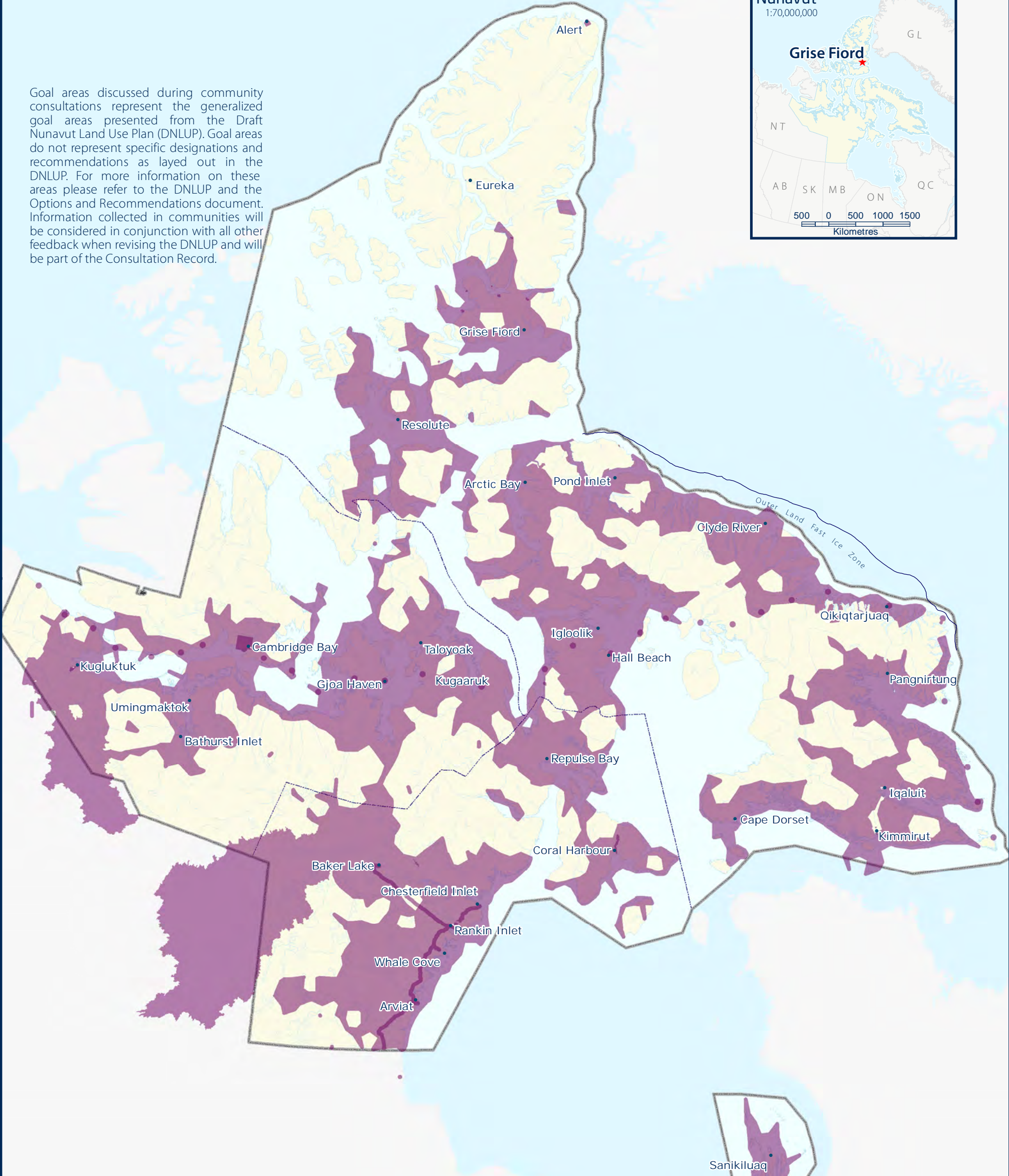



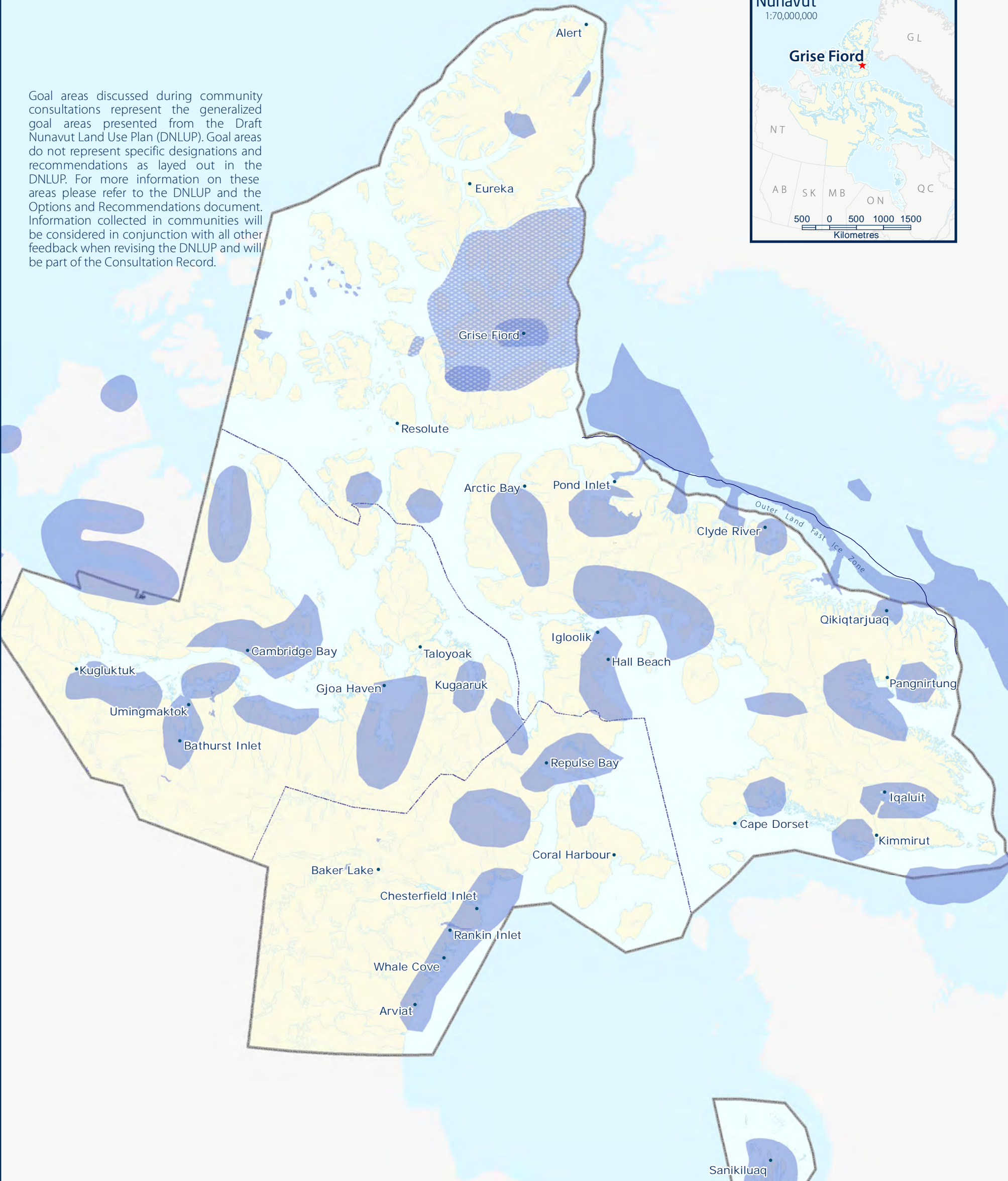

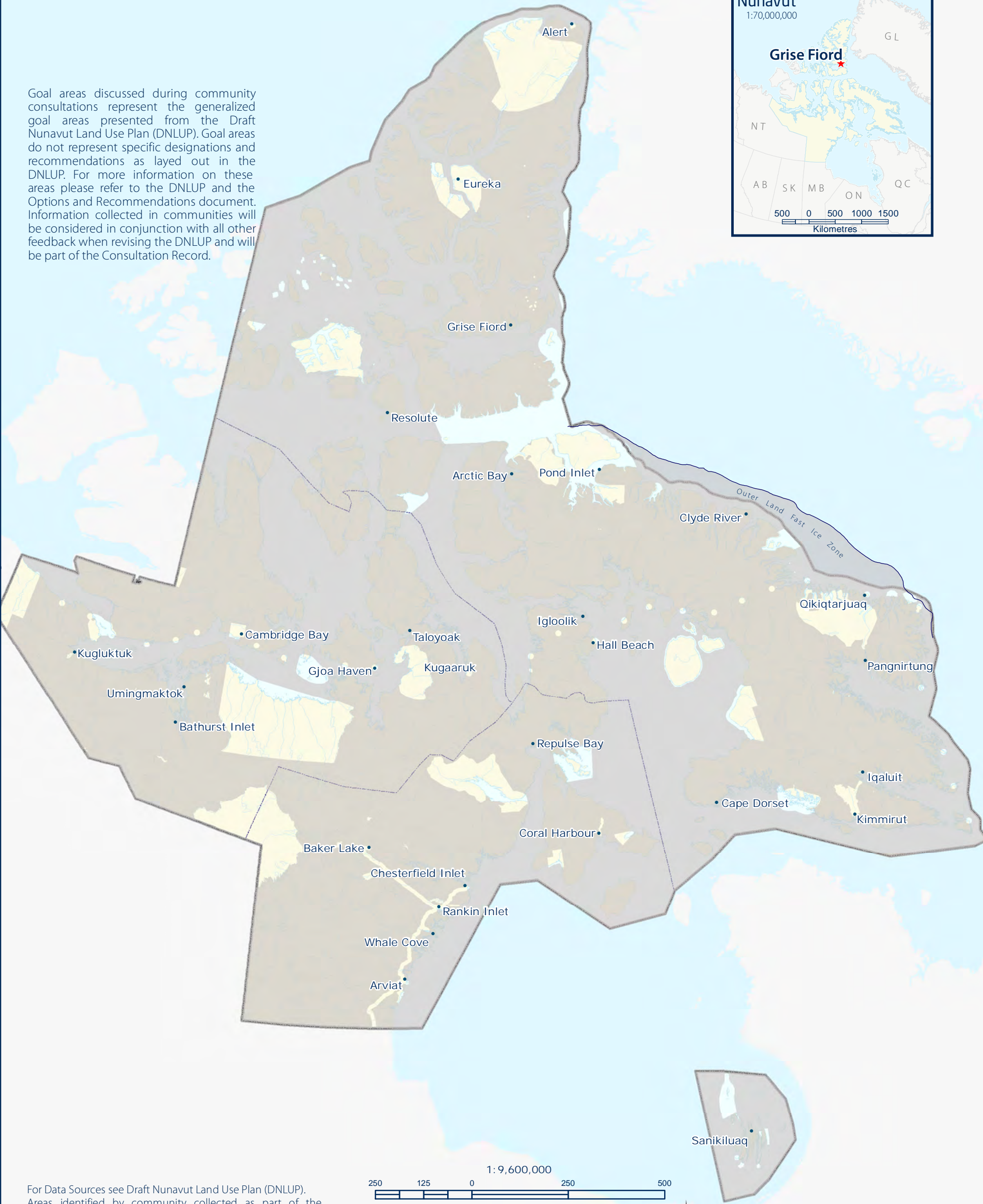

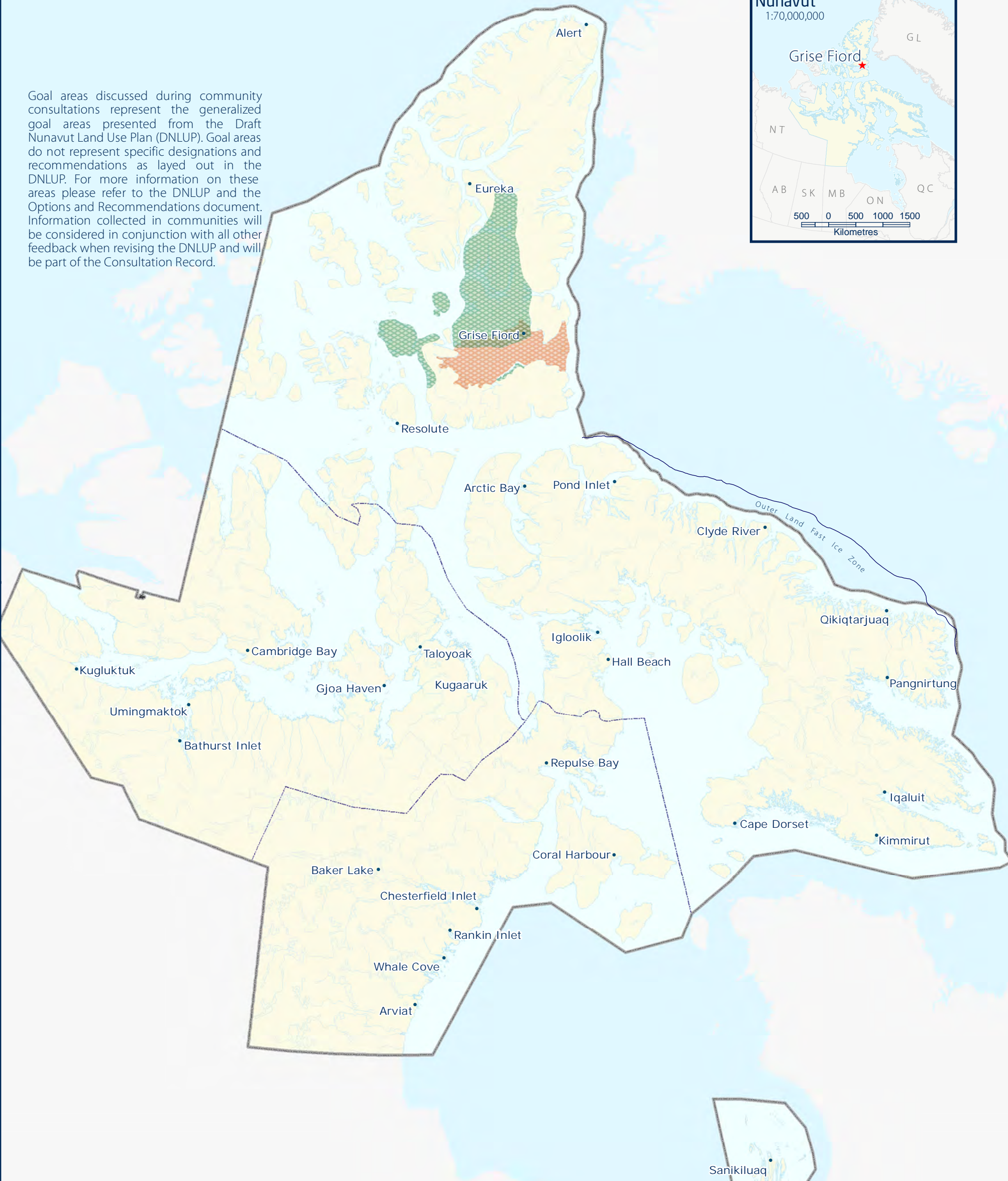

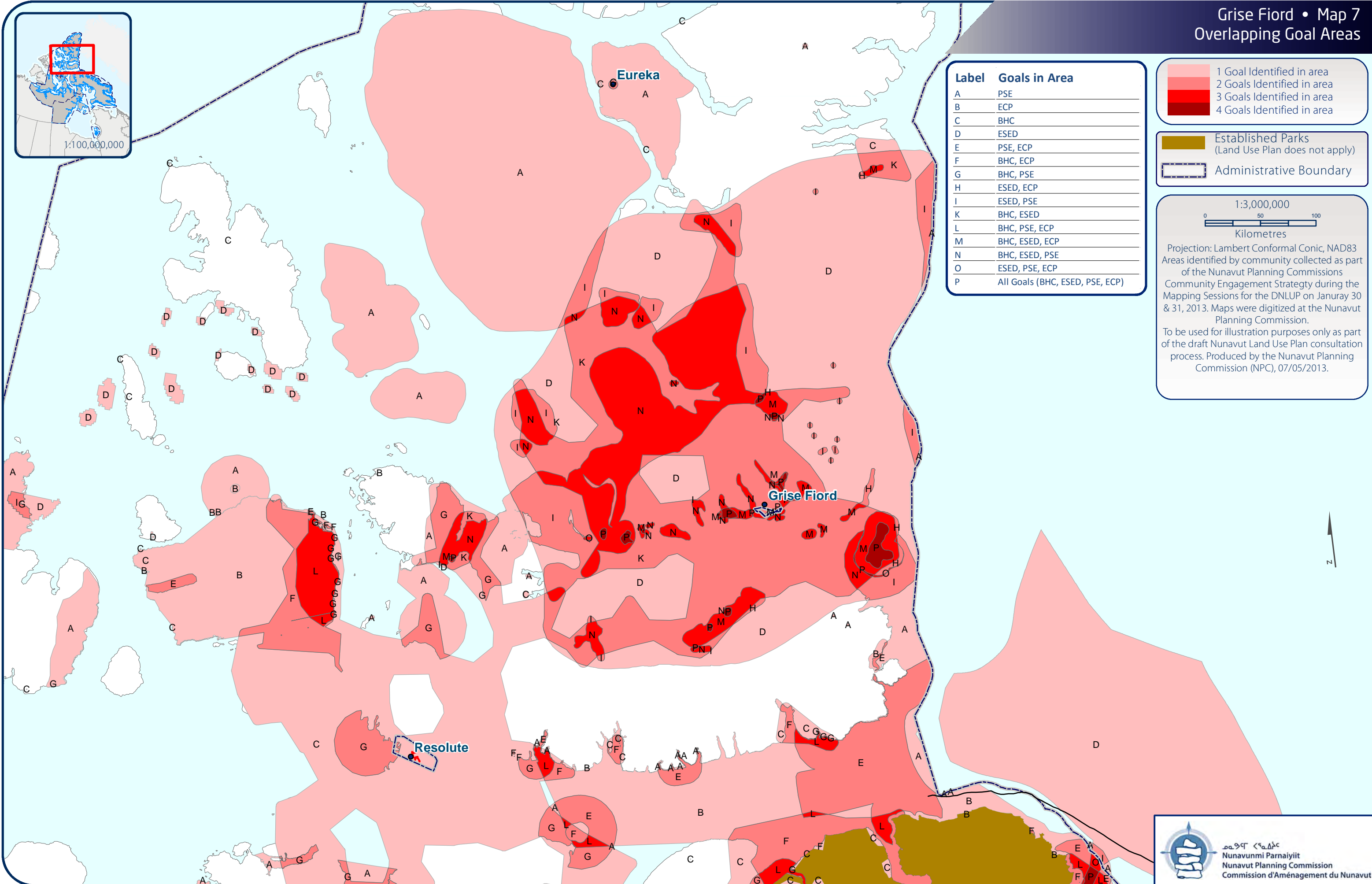

Appendix 1: Open House

During the open house, participants raised the following issues:

- I know lots of important areas like fossil forest, Peary Caribou areas, etc. but if I share that it will attract researchers and tourists. Noise and disturbance - Things changing and scientists say because of weather but maybe because of tourists/researchers.
- Peary Caribou are island caribou, unpredictable, not inland. Caribou and muskox do not mix. Caribou move a lot.
- Hazardous waste - batteries, etc. Bears get into them and lose their fur.
- We need approval/disapproval (message) board to inform people when we locally have approved something, because hunters see research and do not know it is approved.

Appendix 2: Elected Officials Meeting

The elected officials meeting was attended by the Mayor and members of the Hamlet Council and HTO. During the meeting, participants raised the following issues:

- Monitoring of boats is a concern
- Interest in the plan being retroactive
- Concerned with noise pollution – caribou disperse once activity starts



Appendix 3: Questions and Answers

During the community workshop, there was a question and answer period, which included a discussion of the following topics:

- Good presentation. In economic development, sometimes a source of income is hunting/fishing. Export ban has been a factor. How to deal with compensation issue of operators or operations that affect settlement area? Also, is this the right avenue for solar energy - alternate energy - how will land use plan accommodate that?
 - The Commission answered that it is not the Commission's mandate to handle export bans. There are a lot of different areas of program in which alternate energy source can be looked at, including under building healthier communities.
- We know there are areas such as lakes, as much as we try to protect areas - identify areas that need cleaning up before we put rubbish on top of rubbish. Utilization for human beings - not just put coal mine here but how it should be used, protected.
 - The Commission answered that sites that need to be cleaned up can be identified.
- Commission indicated that Lancaster Sound - Hunters both in Resolute and Grise Fiord overlap. This side of Devon, Resolute on other side. How is this handled?
 - The Commission answered that communities may have different views on issues, but the land use plan is about achieving balance between all of the different opinions.
- One of the concerns is who will own the final document. As a hunter I can identify an important bird or walrus, etc area and then researchers, biologists will go and interfere. How do we protect? I would hesitate to tell you about areas, yet I still want to protect it. How do you do that?
 - The Commission answered that this is a common concern and consideration is being given to restricting activities of cruise ships, for example, in important areas that are identified.

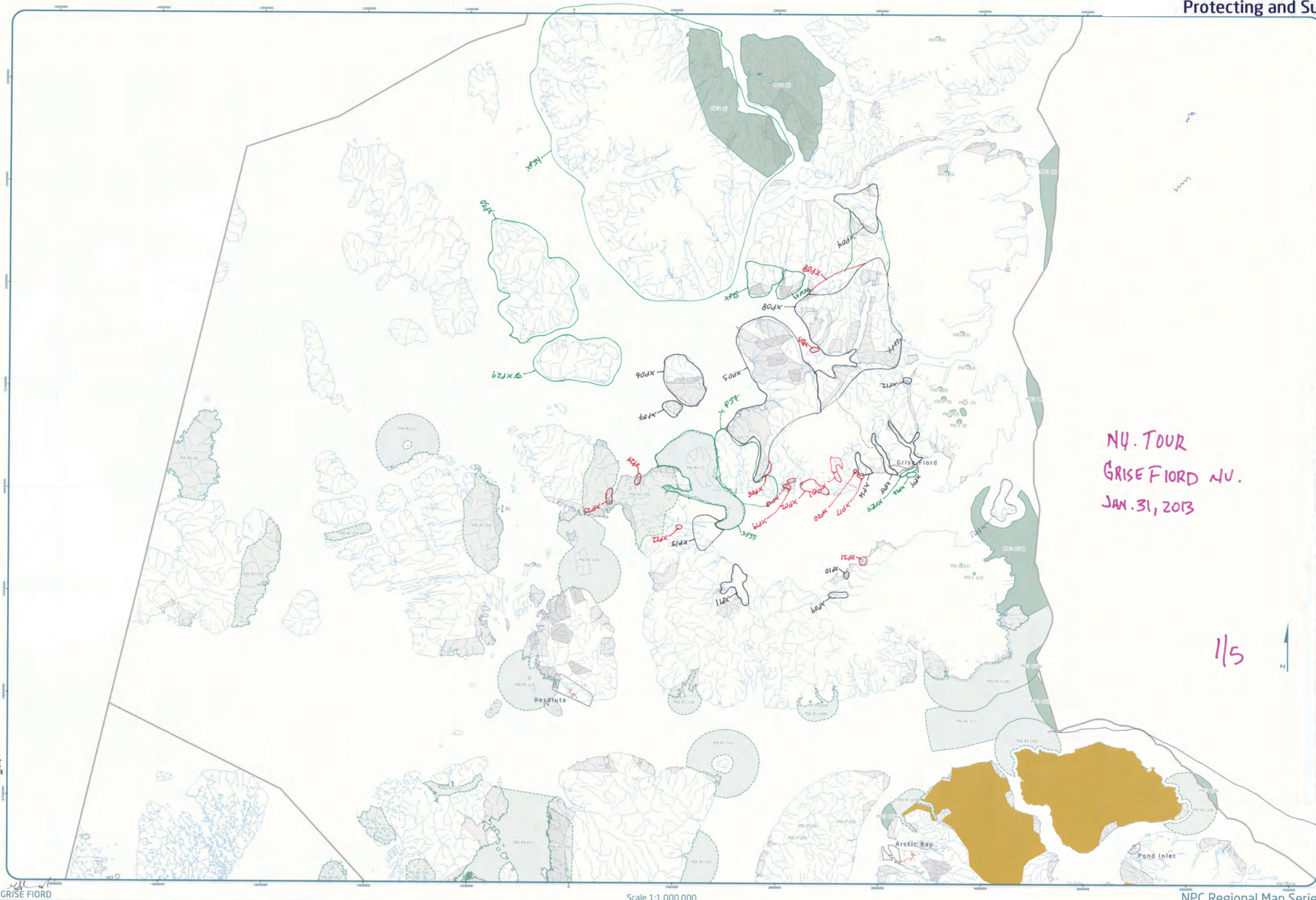
One group completed the mapping session to identify important areas. This Appendix contains the maps that were used by participants to identify areas that are important to the following land use planning goals:

- Protecting and Sustaining the Environment
- Encouraging Conservation Planning

Also included on each map is a reference table that includes the specific values that were identified for the area.

During the mapping portion of the community workshop, the following concerns were raised that did not apply to a specific area that was identified on the maps:

- Our caribou are not the same as the Baffin Island Caribou. They calve differently, not in one area.
- Musk Ox is one of the few species that our quota is high, and can provide commercial value for the community. It is renewable, commercial income for the community. We also have to look at renewable resources.
- Because Caribou move over the years and that they move to other places, we are very concerned as hunters about the area where they are looking for coal, as they will be doing a lot of activity up there this summer even though the Caribou are many. We are concerned.
- At least one participant felt the mapping session was rushed and not all areas were identified.



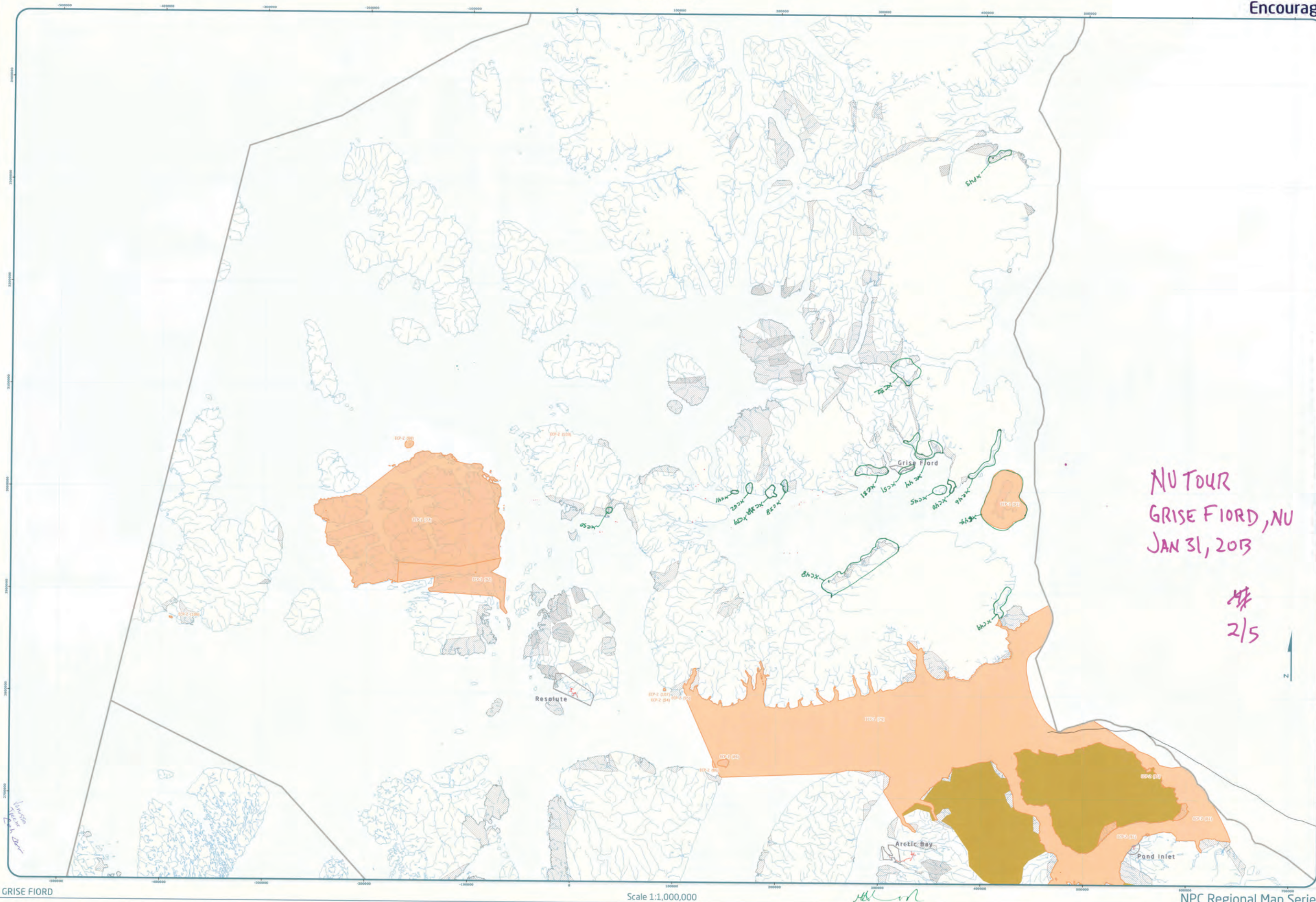
