The Nunavut Planning Commission invites applications for the position of Planner GIS Land Technician to be located at the Commission's office in Iqaluit. The Nunavut Planning Commission is an Institution of Public Government established under the Nunavut Agreement.

Reporting to the Manager, Policy and Implementation, the incumbent is responsible for providing technical expertise in the collection and analysis of spatial and temporal data as well as social and economic information relevant to regional land use planning and resource management.

The ideal candidate will have a degree in **Geography, Land Use Planning or Cartography or Environmental Sciences/Studies, or Natural Resources supplemented with a certificate or diploma in Geographic Information Systems**. The work requires a strong foundation in Geographic Information Systems, cartography, regional geographic study, spatial analysis and land use planning with 3 years' experience. Equivalencies will be considered.

We are looking for a candidate with the following knowledge, skills and abilities:

- Knowledge of computer software programs related to office and lands management
- Knowledge in ArcGIS Server, web mapping tools, web apps, and internet data delivery would be an asset
- Knowledge as to methods of gathering and compiling local and traditional knowledge related to land use issues (Map bio-manual)
- Strong verbal and writing skills
- Ability to plan, organize, supervise and conduct local planning processes
- Ability to gather and analyze demographics, wildlife and habitat, natural resource, social and economic information
- Ability to identify and prioritize land use planning issues related to the conservation, development, management and use of land in the Nunavut Settlement Area
- Ability to participate in and lead work and project teams
- Project Management experience related to comprehensive regional land use planning processes,
- Knowledge of methods and practices of planning, administering and managing a regional program

Priority consideration will be given to qualified applicants who are Beneficiaries of the Nunavut Agreement, individuals with 5 or more year's residency in Nunavut, and to individuals who are fluent in English and Inuktitut or Inuinnaqtun. Candidates must clearly identify their eligibility.
