We offer Isolated Posts Allowances and a Vacation Travel Assistance, as well as a good pension plan, and benefits package, including health, dental and vision, and opportunity for career advancement. If you are a **dynamic and motivated team player** with the desire to be part of a visionary organization, then this is the company for you!

Reporting to the Senior Planner and GIS Land Tech./Planner, the incumbent is responsible for assisting with the implementation requirements of Nunavut Agreement (NA) Article 11, Land Use Planning, and related NA articles. The Jr. GIS Land Tech./Planner provides technical expertise in the collection, digitization, analysis, and representation of spatial data as well as social and economic information relevant to regional land use planning and resource management. The Jr. GIS Land Tech./Planner is also responsible for supporting all cartographic and GIS computer operations in the organization.

We are looking for the ideal candidate with a **combination of education and experience in Land Use Planning and Geographic study, and spatial analysis** with 2 years of related experience. Equivalencies will be considered. Priority consideration will be given to qualified applicants enrolled under the Nunavut Agreement with 8 or more years residency in Nunavut. Candidates must clearly identify their eligibility. **The incumbent will be mentored and have the opportunity to take further education and professional development.**

- Ability to identify and prioritize land use planning issues related to the conservation, development, management and use of land in the Nunavut Settlement Area
- Ability to participate in work and project teams
