The Nunavut Planning Commission invites applications for the position of Senior Planner to be located at the Commission's head office in Cambridge Bay. The Nunavut Planning Commission is an Institution of Public Government established under the Nunavut Agreement.

Reporting to the Manager Planning & Implementation, the incumbent is responsible for managing and providing oversight for all aspects for the effective and efficient implementation of land use plans and the Nunavut Planning and Project Assessment Act (NUPPAA).

The ideal candidate will have a **degree in Land Use Planning or Urban Planning with a minimum of five years' experience** in formulating land use plans or implementing zoning by-laws, knowledge of the environmental assessment. A combination of education, knowledge, skills and abilities may be considered as equivalent to the formal education and experience requirements stated above.

We are looking for a candidate with the following knowledge, skills and abilities:

- Land use planning theories and approaches regarding land use plan formulation, implementation, monitoring and evaluation
- Municipal Land Use Planning Law
- Formulation of procedures for standardizing the administration of a variety of land use planning services related to: rezoning, plan amendments; minor variances; plan review; plan implementation, monitoring and evaluation
- Formulating procedures for standardizing the implementation of land use planning legislation to ensure legal and operational obligations are fulfilled
- Methods of gathering, compiling analyzing and presenting land use planning data and information
- Team building, consultation and interviewing processes
- Advanced computer software programs for office use, the Microsoft Suite of programs, spreadsheets, statistical analysis programs
- An understanding of Geographic Information Systems and Cartographic processes would be an asset
- A wide range of Federal and Territorial regulatory processes related to the management of lands and resources
- Knowledge of the Nunavut Agreement

Priority consideration will be given to qualified applicants who are Beneficiaries of the Nunavut Agreement, individuals with 5 or more year's residency in Nunavut, and to individuals who are fluent in English and Inuktitut or Inuinnaqtun. Candidates must clearly identify their eligibility.
